

VERIFICATION OPINION DECLARATION GREENHOUSE GAS EMISSIONS

To: The Stakeholders of Russell Reynolds Associates

Apex Companies, LLC (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Russell Reynolds Associates (Russell Reynolds) for the period stated below. This verification declaration applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of Russell Reynolds. Russell Reynolds is responsible for the preparation and fair presentation of the GHG emissions statement in accordance with the criteria. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information. Apex is responsible for expressing an opinion on the GHG emissions statement based on the verification. Verification activities applied in a limited level of assurance verification are less extensive in nature, timing and extent than in a reasonable level of assurance verification.

Boundaries of the reporting company GHG emissions covered by the verification:

- Operational Control
- Worldwide

Types of GHGs: CO₂, N₂O, CH₄, HFCs

GHG Emissions Statement:

2019:

- Scope 1: 247 metric tons of CO₂ equivalent
- Scope 2 (Location-Based): 1,551 metric tons of CO₂ equivalent
- Scope 2 (Market-Based): 1,944 metric tons of CO₂ equivalent

2020:

- Scope 1: 315 metric tons of CO₂ equivalent
- Scope 2 (Location-Based): 1,337 metric tons of CO₂ equivalent
- Scope 2 (Market-Based): 1,482 metric tons of CO₂ equivalent

2021:

- Scope 1: 358 metric tons of CO₂ equivalent
- Scope 2 (Location-Based): 1,432 metric tons of CO₂ equivalent
- Scope 2 (Market-Based): 1,597 metric tons of CO₂ equivalent

Data and information supporting the Scope 1 and Scope 2 GHG emissions statement were primarily historical in nature and in some cases estimated.

- 2019: January 1, 2019 to December 31, 2019
- 2020: January 1, 2020 to December 31, 2020
- 2021: January 1, 2021 to December 31, 2021

Criteria against which verification was conducted:

World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD)
Greenhouse Gas (GHG) Protocol Corporate Accounting and Reporting Standard

Level of Assurance and Qualifications:

- Limited
- This verification used a materiality threshold of ±5% for aggregate errors in sampled data for each of the above indicators

GHG Verification Methodology:

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of Russell Reynolds;
- Review of documentary evidence produced by Russell Reynolds;
- Review of Russell Reynolds data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of sample of data used by Russell Reynolds to determine GHG emissions.

Verification Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions statement shown above:

- is not materially correct and is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard

It is our opinion that Russell Reynolds has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.
